### **Sub: Re-Constitution of Committee for SC/ST**

With a view to prevent atrocities on the Scheduled Castes and the Scheduled Tribes as per the Scheduled Castes and the Scheduled Tribes, (Prevention of Atrocities) Act, 1989, No.33 of 1989, dated 11.09.1989, the "Committee for SC/ST" for the Academic Year, 2026-27, at the New Delhi Institute of Management is re-constituted due to change in committee with the following Members:

The committee shall organize awareness workshops at the beginning of each semester or as and when required to educate the students belonging to the SC and ST about their rights and the protection available to them under the provisions of various Central and State enactments or rules, regulations and schemes framed there-under. The committee shall also identify the areas where it has reason to believe that atrocity may take place or there is an apprehension of reoccurrence of an offence. The committee shall make investigations about the probable cause leading to an offence under the Act and restoring the feeling of security amongst the students of the SC and ST.

In every quarterly meeting, the committee shall review the situation and the cases registered, if any, under the Act.

The Tenure of the Committee will be for three years.
